Our organic cotton service

The smallholder farmers in India and Tanzania only use GMO-free seeds and cultivate their fields without the use of chemical or synthetic pesticides or fertilizers. Controlled seed is the base for the complete traceability of our organic cotton. The organic cotton is grown in crop rotation to preserve soil fertility and biodiversity to prevent soil erosion. The organic cotton in Tanzania is exclusively rainfed, i.e. there is no artificial irrigation. In India, the fields are partially irrigated using the water-saving drip irrigation system. Harvesting is done by hand on both continents. The organic conformity is tested and certified by recognised and independent certification bodies.




