Applicable to: All business areas, subsidiaries, and suppliers of Remei AG

## 1. Introduction

Remei AG is an internationally active trading company for yarn, textiles, and apparel made from organically grown and fairly traded cotton. Our business model is based on transparency, ecological integrity, and social responsibility throughout the entire textile value chain.

In accordance with the Global Organic Textile Standard (GOTS) Version 7.0, the OECD Guidelines for Multinational Enterprises, and the UN Guiding Principles on Business and Human Rights, Remei AG is committed to responsible corporate governance throughout its global supply chains.

# 2. Principles of our actions

We are committed to avoiding negative impacts of our business activities on people and the environment and, where they do occur, to taking effective remedial action. This applies in particular to:

- Human rights
- Working conditions
- Environmental protection
- Prevention of corruption

This commitment extends to all stages of the supply chain, from the cotton field to the finished product – from fibre to fashion.

We use a structured due diligence system that comprises the following core processes:

#### 4.1 Risk analysis:

- Regular identification and assessment of human rights and environmental risks
- Prioritization according to probability of occurrence and severity of impact

#### 4.2 Prevention and remediation:

- Development of concrete measures to minimize risk
- Promotion of fair working conditions and environmental standards

## 4.3 Monitoring and evaluation:

- Conducting internal audits and external verifications
- Monitoring and evaluation of certificates and audit results, as well as corrective actions

#### 4.4 Transparency and communication:

- Public reporting on our due diligence measures
- Active communication with stakeholders
- Traceability information on the finished product (in the form of a digital product passport)

#### 4.5 Complaint mechanism:

- Establishment of a confidential complaint mechanism
- Commitment to fair and timely processing of all report
